The Law Library Fund, Talladega County, Alabama, (herein referred to as the “Law Library Fund”) was established by Act Number 79-592, Acts of Alabama, as amended by the following acts: Act Number 81-125; Act Number 81-1044; Act Number 90-430; Act Number 2002-283; Act Number 2002-447; and Act Number 2005-139. Revenues, which consist of various court costs, are to be expended according to the provisions of these various acts.

Honorable Julian M. King served as Presiding Circuit Judge during the examination period.

This report presents the results of an examination of the Law Library Fund and a review of compliance by the Law Library Fund with applicable laws and regulations of the State of Alabama in accordance with the requirements of the Department of Examiners of Public Accounts under the authority of the *Code of Alabama 1975*, Section 41-5A-12, as added by Act Number 2018-129.

Tests performed during the examination did not disclose any significant instances of noncompliance with applicable state or local laws and regulations.

The Official was invited to discuss the results of the examination at an exit conference held at the Presiding Circuit Judge’s Office. Representing the Department of Examiners of Public Accounts was Jimmy Flowers, Examiner of Public Accounts.
