



**SUMMARY**

**Law Library Fund  
Crenshaw County, Alabama  
August 1, 2016 through June 30, 2019**

The Law Library Fund, Crenshaw County, Alabama, (hereinafter referred to as the “Law Library Fund”) was established in February 1981, by resolution of the Crenshaw County Commission in accordance with the *Code of Alabama 1975*, Sections 11-25-1 through 11-25-13. The Law Library Fund receives library fees collected in the Circuit and District Courts of Crenshaw County and in the municipalities of Luverne, Brantley, and Dozier in Crenshaw County, Alabama. Funds are disbursed for the maintenance of the library and to provide legal material needed by the County, court officials, and citizens of the County. The Presiding Circuit Judge of the Second Judicial Circuit is to administer the Law Library. An advisory committee was appointed by the Presiding Circuit Judge pursuant to the *Code of Alabama 1975*, Section 11-25-6.

Honorable Terri Lovell served as Presiding Circuit Court Judge during the examination period.

This report encompasses an examination of the Law Library Fund and a review of compliance by the Law Library Fund with applicable laws and regulations of the State of Alabama in accordance with the requirements of the Department of Examiners of Public Accounts under the authority of the *Code of Alabama 1975*, Section 41-5A-12, as added by Act Number 2018-129.

Tests performed during the examination did not disclose any significant instances of noncompliance with applicable state or local laws or regulations.

The Official was invited to and attended, via telephone, an exit conference to discuss the results of this examination. Representing the Department of Examiners of Public Accounts was Gary Kelly, Examiner.
